

SANCOLD ANNUAL REPORT 2021

OVERVIEW 2021

The year 2021 was severely impacted by the Covid 19 pandemic and accompanying lockdowns. The SANCOLD 2020 conference was cancelled and activities limited to virtual events. A major effort was placed on cleaning up the membership database which will result in the membership of a significant number of members in arrears having their membership terminated.

1. SANCOLD MANAGEMENT COMMITTEE

Elections were held at the end of 2020 for two vacant positions. Four candidates were nominated of which two were under 35.

Robert Greyling and Janice Zhang were duly elected. Robert Greyling was elected as Vice-Chairperson of SANCOLD. Louiza van Vuuren was appointed as YPF Chair but has subsequently resigned for personal reasons. A member will be co-opted to serve the remaining 12 months of her term of office. The other portfolios remained as in the previous year. Four co-options were made as indicated below

2. OBJECTIVES FOR 2021

With Covid 19 restrictions applying, most SANCOLD and ICOLD activities were severely impacted and many objectives were not achieved.

3. MEMBERSHIP MATTERS

Individual membership increased significantly during the year but was offset due to terminations as a result of non-payment by both Individual and Corporate Membership.

The Corporate Membership growth has dropped due to mergers, resignations and terminations.

Some problem was experienced during the year with e-mail communications with members as it appears as if some members are not receiving the SANCOLD e-mails and notices. 4. SANCOLD LOCAL ACTIVITIES

SANCOLD focussed on a number of local matters during the year, the foremost being:

- A Dam Safety Surveillance Course was held at Driekoppies Dam on 11-13 May. Although this was held at short notice, there were 12 participants. Due to wide interest, it is intended to repeat the course later.
- On 2 June the YPF held a webinar entitled "The Latest Developments in Concrete Engineering" presented by Dr Quentin Shaw.
- Another later YPF webinar was postponed due to the ill health of the presenter.
- SANCOLD provided financial support of R50 000 in 2021 to each of two post graduate students whose research links into furthering SANCOLD work.
- SANCOLD remains concerned about issues around APP Training/Legislation change. This remains a priority but SANCOLD still needs to develop a realistic and workable strategy to take this forward.
- Expansion of SANCOLD Working Groups related to ICOLD Committees on which SANCOLD has representation;
- Relevant information sent to members and African National Committees via direct e-mailing;
- Publication of SANCOLD information in local and international journals.
- Updating the SANCOLD website;
- Preparations for the SANCOLD 2021 Annual Conference and Annual Meeting.

- The Guideline on Ecological Water Reserve brochure is being finalised for publication. Gerald de Jager is the Convenor of the initiative;
- The various SANCOLD Working Groups for SANCOLD Guidelines and Publications are given below.

5. SANCOLD YOUNG PERSON'S FORUM

A Young Engineers' Forum in ICOLD was formed in Lucerne in 2012. SANCOLD agreed that SANCOLD should form a similar Forum in South Africa and once operational would liaise with the ICOLD Forum. Guy Robertson of JGAfrika is the current Chairperson. Currently we have over 50 members of the Forum which has been guite active.

6. INTERNATIONAL ACTIVITIES

The other main activity of SANCOLD relates to international matters. SANCOLD represents South Africa on the International Commission on Large Dams (ICOLD). We have representation on 21 of ICOLD's 27 Technical Committees. These Committees are a key activity of ICOLD and require much dedicated effort on the part of the participants. South African Working Groups have been formed for most of these Committees and the names of the current participants are reflected in the tabulation below.

10. CONCLUSION

- This year has been severely impacted by Covid 19 restrictions with few activities taking place.
- SANCOLD Individual membership is showing healthy growth specially among younger members but both Individual and Corporate membership have drppped as a result of termination due to non-payment.
